InCommon - A Trust Framework

- Shared Risk to provide Common Benefit
- Common (US) legal basis
- ... mapped to a common technology basis
- Trusted source of metadata
 - Service end-points (URLs and public keys)
 - Certifications of specific aspects of trust
 - Contact information, *etc.*
- Transparency of operations
- Community engagement

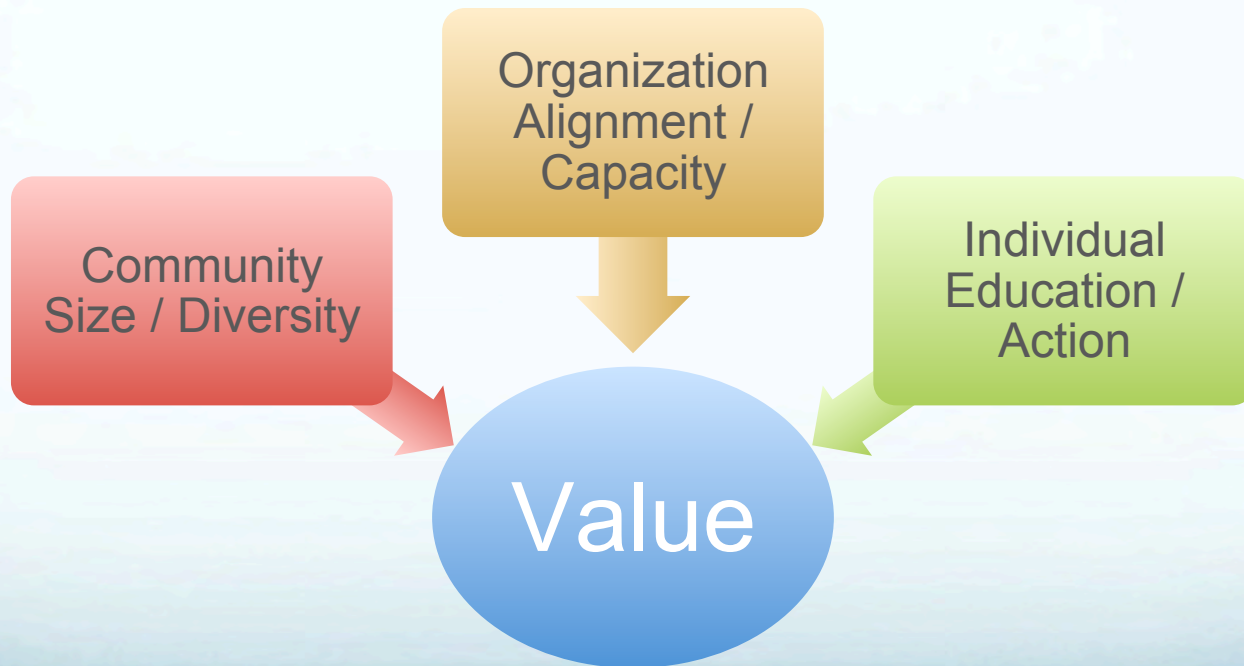

Activities - Increasing Trust

- Baseline practices work groups
 - Technology, operation, assurance
- Multi-factor authentication (MFA)
 - MFA Cohortium
 - Interoperability for federated MFA
- Research & Scholarship (R&S) and other Entity Categories
 - COPPA Compliant?
- Trustmarks

Activities - Managing Risk

- Encouraging appropriate attribute release
 - Support for collaboration
 - User consent
- Federation operations
 - Ongoing security review
 - Help desk
- Incident response

Activities - Helping Participants

- **Alternative IdPs Working Group**
 - Alternative software and outsourcing strategies for federation
- **External Identities Working Group**
 - Use of non-local identities in various scenarios
- **Multi-Context Broker (MCB)**
 - Support for federated MFA and assurance
- **TIER**
 - Solutions for campus IAM, including federation

Activities - Community Engagement

- Better understanding of community needs
 - New membership shifting to schools with fewer resources for identity management
- More targeted information resources
 - Research
- Ongoing strategic planning
- IAM Online, I2 Technology Exchange, I2 Global Summit, *etc.*
