#### Update on pilot planning stemming from Quilt/InCommon Federation Workshop

Goal / purpose of the pilot program is to flesh out and validate some business and technical models that can help move federation into K12 and community colleges. It is expected that the pilots will generate case studies / documentation around federation, to provide reference material and guidance to others moving forward.

MikeD reported that Nebraska has been looking at federation issues for several years. They are excited about InCommon and the pilots.

They hope to develop documentation to contribute back to the community.

Q: Are there pilot happening already?

A: The planned pilots are the first under the InCommon Quilt umbrella, but some districts around the country are most likely already piloting or moving forward with federated models
